- 6. Team A is attempting a two-point try. A1's legal forward pass is intercepted by B2, who advances to his own seven yardline. When an official sounds the whistle.

- Ruling 7: The ball is dead when it strikes the pylon. The result of the play is a touchback. Team B will begin a new series at its own 20 yardline (1-2-4, 4-2-2b, 8-5-3c, 8-5-4)
- Play 8. Team K's kick try comes up short. R1 catches the ball in the end zone and advances to team R's 40 yardline. During the run, R2 clips in the end zone. What is the ruling?
- Ruling 8: The ball was dead as soon as it broke the place of the goaline and it was apparent the kick would fail. The 15-yard penalty ro R2's clipping foul is enforced as a dead-ball foul from the succeeding spot (4-2-2d-2)
- Play 9. Fourth and seven from team B's 25 yardline. B1 intercepts a pass at his own size yardline. After running a few steps, he is hit and fumbles. The ball rolls and hits the pylon, which is properly placed. What is the ruling?
- Ruling 9: Safety, team A scores two points. The pylon marks the intersection of the goal line and sideline and is out of bounds when properly placed. The force that caused the ball to go out of bounds in the end zone is B1's fumble. (1-2-4, 2-13-2, 8-5-2b)
